• Financial Report

- Significant item = Trash, insurance, utilities, lifeguards, maintenance, contingency & lawnmowing
- o Ended the year with \$71,017.87 in our reserve (bank) account.
- The wind storm in July was quite an expense to the entire neighborhood, around \$9,000 in cleanup.
- o 2024 income is projected @ \$175,300: Expenditures are projected at \$166,950
- Significant increases: Taxes = higher wages for lifeguards, higher taxes;
 Lifeguards = higher beginning wages, training (certification); Pool Maintenance =
 Always an expense, fixed the pumps by replacing the sand (\$3,000) Freeze issues in the bathrooms, backflow valve replaced. plumbing issues; Pool Chemicals =
